#### APPOINTMENT PROCESS

Following the receipt and review of all applications, the STF Executive shall appoint members considering:

- Has the member ever been found guilty by a professional disciplinary committee of the teaching profession that resulted in a penalty of reprimand, fine or suspension or cancellation of his or her teacher's certificate?
- Has the member demonstrated, through his or her resumé, references and declaration, that they have the necessary experience, character and commitment to serve and protect the public and act in the public interest as a member of the board regulating the teaching profession in Saskatchewan?
- Does the member have leadership skills, a commitment to lifelong learning, strong communication skills and a strong sense of ethics?
- Among qualified candidates, is there an opportunity to achieve representation through diversity of career stage, gender, cultural heritage and geographical location?

Successful applicants will be notified by the Executive Director, in writing, the members who have been appointed to the SPTRB Board of Directors and, upon confirmation of their acceptance, shall notify, in writing, the Chief Executive Officer of the SPTRB of the appointments.

The STF Executive will notify all members of the Federation's appointment of an SPTRB Board member upon confirmation of the appointee's acceptance and SPTRB's acknowledgement.
